# COMMON COUNCIL MEETING OF THE CITY OF BOX ELDER DRAFT MEETING MINUTES Tuesday, July 15, 2014, 7:00 p.m.

A scheduled meeting of the Common Council of the City of Box Elder was called to order at 7:00 pm on Tuesday, July 15, 2014. - 2. Pledge of Allegiance and moment of silence.
- 3. Roll Call: Present: Allen; Cowley; Coatney; Curry; Haddenham. Absent: Hollinshead.
- 4. Approve Agenda

Motion by Allen, seconded by Coatney to approve the agenda. Vote Aye: Unanimous.

- **5. PRESENTATION:** Presentation from Dustin with Pennington County Emergency Management.
- **6. PRESENTATION:** Certificates from Mayor presented to the Box Elder Chamber, BEPD, BEVFD, BEPW participation in the 2014 Box Elder Bash. - **B. PLANNING/ZONING DEPARTMENT:** Motion by Allen, seconded by Cowley to approve Resolution 14-13, a resolution to vacate a setback easement for property located at 22569 Westgate Road. Vote Aye: Unanimous.
- **C. FINANCE DEPARTMENT:** Motion by Coatney, seconded by Cowley to approve Resolution 14-14, a resolution consenting to transfer of franchise. Franchise transfer is from Knology to Clarity. Vote Aye: Unanimous.
- **D. PLANNING/ZONING DEPARTMENT:** To approve and adopt Project Plan for TIF #2.

Extensive discussion on TIF#2.

Motion by Coatney, seconded by Allen to defer to the August 5th meeting. Vote Aye: Unanimous.

#### 10. DEPARTMENT HEAD REPORTS TO COUNCIL:

Mayor: Griffiths invited the council members to the Mayor's luncheon next Thursday at noon in the event center.

Police: Chief Dubbs gave the department statistics report for July 1<sup>st</sup> to 14<sup>th</sup> with an update on upcoming staff trainings. He also reminded people of the blood drive on July 22<sup>nd</sup> in the Box Elder Event Center, to register please call him.

Public Works: Director Todd explained we are waiting on quotes for asphalt; Creekside Park equipment is up; we are still working on the other parks; Ghere Well is on line and we have received complaints on the hardness of the water; we are working with Hawkins to see about the hardness of the water. Resident Rick thanked public works for the work on Line Rd. Resident Maine expressed concern of standing water around some of the equipment in Boykin Park.

Finance: Officer Lashwood let everyone know that we are getting ready for budget hearings, the agenda packets will be ready sometime tomorrow afternoon. Resident Maine asked about the time and dates for the budget meetings. Budget meetings are July 21, 22, and 23 (if needed) from 6-8pm.

Planning/Zoning: Director Koan thanked Scott and Steve for sitting in on meetings with different agencies and businesses that want to move out to Box Elder. If they do come into Box Elder it will benefit the business community and bring in a lot of sales tax. Resident Maine added that if we want businesses to come in we need businesses on Box Elder Rd West to start cleaning up.
