Section Two

That there is hereby levied on all taxable property within the City of Box Elder, South Dakota for the purpose of providing funds to meet the lawful expenses and liabilities of the City of Box Elder, South Dakota, as set forth, for the Fiscal year 2011, a tax sufficient to raise the following amount, which is to be received by the City Finance Officer and credited to the following funds:

General Fund \$ 779,651.00

For General Municipal Purposes \$779,651.00 divided by taxable valuation of \$160,427,064.00(Pennington) and \$41,125,237 (Meade) equals a mill levy of \$4.86

Section Three

The City Finance Officer is hereby authorized and directed to certify the dollar amount of the property tax levies stated in this ordinance to the Pennington County Auditor.

Section Four

That all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of conflict only.

Section Five

This Ordinance and Budget recognizes the following appointments:

Chief of Police is appointed as Timothy Ryan 2011 salary is 47940 yearly until Feb 2011 when his salary adjusts to 48500
 Finance Officer is appointed as Debbie Knapp 2011 salary is 41213.14 yearly
 Public Works Director is appointed as Al Todd 2011 salary is 44553.60 yearly
